The following is a year-end report for the Lake Ozark Fire Protection District. This report contains a breakdown of the incidents the district responded to, code enforcement activities, training classes that were conducted for members of the district, and community events that the district participated in.

2019 was again another busy year. One of the biggest things that the district did in 2019 was putting a third ALS ambulance in service for the citizens of the fire district. To do this, the district hired 11 personnel to be able to staff the ambulance. A second accomplishment for the district was to refinance the 2012 bond. By refinancing the bonds, the district was able to save over \$120,000 over the remaining years of the bond repayment period. Also, in 2019, the fire district was awarded an Assistance to Firefighters Grant for new radios. This was a regional grant with Osage Beach Fire Protection District, and we were able to purchase 20 mobile and 25 portable radios. The grant total was \$483,000.

With the continued support from the public, the fire district will continue to train and explore ways to provide the highest level of service to the public.

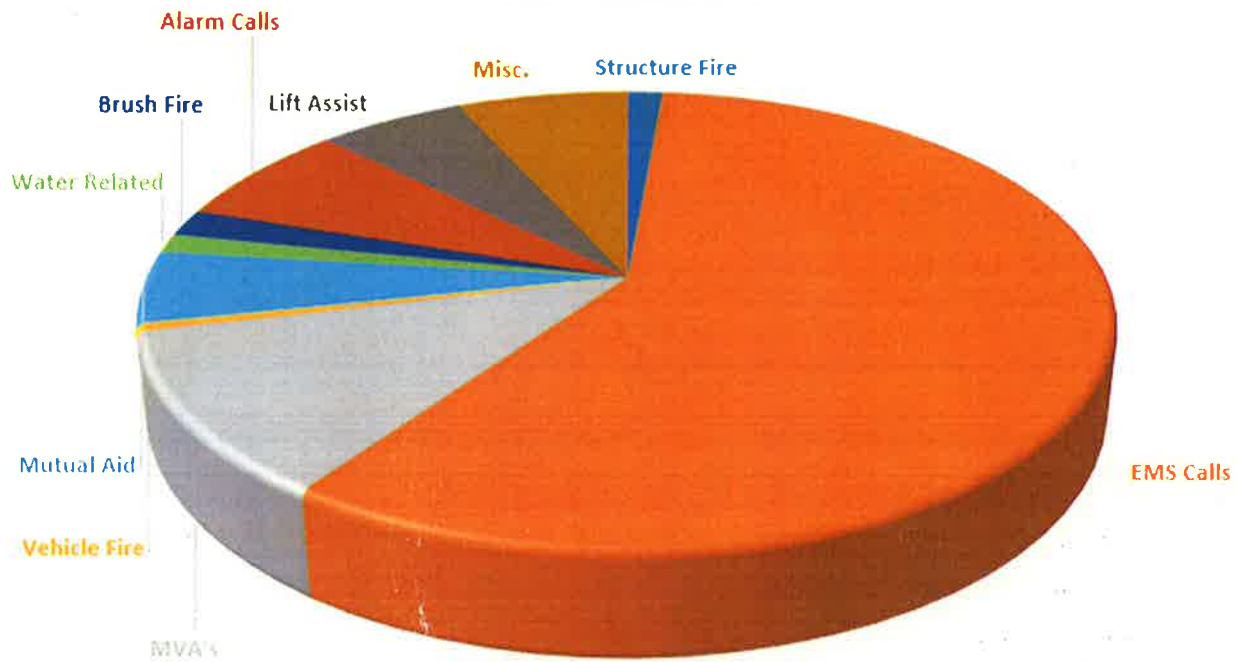

# Building Division

2019 continued to see continued activity. The district issued 365 permits which was more than in 2018. These permits included: dock inspections, residential and commercial new construction, residential, and commercial remodels. A total of 554 inspections were conducted in 2019. Along with these inspections, the district conducted numerous safety inspections, wildfire hazard assessments, and pre-plan surveys.
